Abstract submission deadline: Friday 26 June 2026, 23:59 PDT

Submission of an abstract constitutes acceptance of these Abstract Submission Terms and Conditions

Authorship Eligibility and Responsibility

By submitting an abstract, the submitter confirms that all listed authors meet the following authorship criteria:

- Have made substantial contributions to the conception or design of the work or the acquisition, analysis, or interpretation of data; AND
- Have been involved in drafting the work or reviewing it critically for important intellectual content; AND
- Have provided final approval of the version to be published; AND
- Agree to be accountable for all aspects of the work, ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.

Each author should be able to identify which co-authors are responsible for specific other parts of the work and should have confidence in the integrity of their co-authors' contributions.

These authorship criteria are aligned with the recommendations of the [International Committee of Medical Journal Editors](#).

The submitter also confirms that:

- All authors have read and approved the abstract prior to submission and agree to be listed in the abstract;
- The submitter has the authority to act on behalf of all authors in all matters relating to the submission;
- All authors have approved the submission of the abstract to the Congress.

Originality, Plagiarism and Use of Artificial Intelligence

Submitted abstracts must represent original work. Abstracts may be assessed using electronic screening software to identify potential plagiarism or inappropriate use of artificial intelligence (AI) in content generation. The use of AI to assist in refining language, improving grammar, and optimising structure is generally accepted, provided the core research and conclusions are verified by the human authors.

An abstract may be rejected if there is:

- Apparent duplication of another submitted abstract;
- Apparent duplication of previously published work (plagiarism);
- Apparent inappropriate use of AI to generate the abstract content.

If plagiarism or inappropriate use of AI is suspected, the submitter will be notified and asked to provide confirmation that the work is legitimate and such practices have not occurred. If satisfactory confirmation is not provided, the abstract will be rejected.

Abstract Review and Disposition

All abstracts submitted to the Congress will be reviewed by members of the Scientific Committee. The Scientific Committee reserves the right to:

- Determine the final presentation format;
- Schedule accepted abstracts within the programme;
- Reject abstracts that do not meet the required standards.

The decision of the Scientific Committee is final.

Author Attendance

If an abstract is accepted, at least one named author must register for and attend the Congress to present the abstract in the assigned format (oral or poster). The Congress organisers reserve the right to withdraw an abstract from the programme and/or publication if this requirement is not fulfilled.

Withdrawal Policy

Authors who wish to withdraw their abstract at any time prior to the withdrawal deadline must write to the Congress Secretariat at hivglasgow@ashfieldmedcomms.com, quoting the abstract title, the name of the presenting author, and the reference number issued upon submission.

Requests for withdrawal must be received by **Friday 4 September 2026**.

Data Storage and Protection

By submitting an abstract, the submitter confirms that all authors:

- Agree that personal details provided as part of the submission may be stored in the Congress database for the purposes of abstract review, programme planning, publication, and communication regarding the submission;
- Understand that author information may be shared with the *Journal of the International AIDS Society (JIAS)* if the abstract is accepted for publication.

Permission to Publish

By submitting an abstract, the submitter confirms that, if accepted, the authors consent to publication of the abstract in the supplement to *JIAS*.

Abstracts will be published under the [Creative Commons Attribution \(CC BY\) license](#). The license allows third parties to share the published work (copy, distribute, transmit) and to adapt it under the condition that the authors are given credit, and that in the event of reuse or distribution, the terms of this license are made clear.

Authors retain copyright of their abstracts, with first publication rights granted to *JIAS*.
